Normandy Drop Zone Tours does not own or operate any entity that provides goods or services for your tour including, for example, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of excursions, museums, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, Normandy Drop Zone Tours is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party. RELEASE

If the dispute cannot be resolved through mediation then (b) the dispute shall be submitted for binding arbitration through the American Arbitration Association in Davie, Florida; (c) the dispute will be governed by Florida law; and (d) the maximum amount of recovery to which I will be entitled under any and all circumstances will be the land cost of my tour with Normandy Drop Zone Tours, LLC.
